Fate of Foreclosed Home Soon Final

Front of 3195 Condit Road, Lafayette or neighbors, it can't happen soon enough. In an area with freshly painted homes, neatly mowed lawns and lush rose bushes, this house looks more than a little out of place. They have been patiently waiting for someone to demolish or start seriously remodeling this home on the corner of Condit Road and Pleasant Hill Road that's been declared a public nuisance.

As reported in January of this year, selling this foreclosed house can only be described as challenging. "This home slipped through the cracks," said Carolyn Lacy, Contemporary Home Solutions Manager, "Nobody could figure it out." A Notice of Default was issued by Countrywide Bank in March of

Photo Cathy Tyson 2008, but they also filed a Notice of Rescission less than a month later. A Notice of Rescission cancels or annuls the effect of a Notice of Default.

For almost two years the property languished - the homeowner erroneously believed the property had been foreclosed by the bank. A flurry of official notices and certified letters were ignored, from Notice to Comply to Notice of Violation Lien and more.

In the middle of the original process, Countrywide Home Loans was purchased by Bank of America. Bank of America finally issued another Notice of Default on the property in March, 2010 and has a Trustee Sale scheduled for July 17, 2010. Interested parties are invited

to bid at public auction for the property, with the home ultimately going to the highest bidder.

The home was purchased in August of 2004 for \$845,000 via a nothing-down first and second mortgage through Countrywide Home Loans. For real estate investors, that was a lifetime ago, when demand out-stripped supply, before anyone had heard of a credit default swap.

"Trespassers continue to break into the property. The presence of an empty swimming pool and the use of candles at night pose risks to trespassers as well as neighbors. The City of Lafayette wants to eliminate such risks by demolishing the structure and filling in the pool prior to the trustee sale. Efforts are currently underway to petition the Courts to allow this to happen," said

Bank of America is trying to do the right thing and has assigned a representative from their Field Services Department to clean up and secure the property. "I'm working with Bank of America on property maintenance," said Greg Wixom, County Building Inspector, "I visit the property every week to make sure B of A is meeting their end of the bargain." He's also working with Mosquito Abatement and checks on the water level of the pool to make sure its less than 18 inches deep.

Cost of Parking Tickets Going Up in Lafayette

hat expired meter will soon cost drivers \$5 more. Meters and every other violation will be a bit pricier in the near future to pay for SB1407. Parking scofflaws may not recall voting for the passage of this bill, which established a State Court Facilities Construction Fund, but they will soon be responsible for an extra \$3 for court construction costs that will be added to each citation, in addition to the \$1.50 that the State is now authorized to take. Lafayette City Council recently approved the \$5 increase recom-

mended by City staff. What's a new ticket going to cost? Depends on the ticket but for most common violations - like an expired meter, or parking in a no parking zone or loading zone, the new and improved tickets will cost \$30. Even leaving keys in a parked vehicle will cost you \$30, if sighted. Parking in a handicapped space will set you back \$280. Parking in a bus zone is also quite pricey at

It's unclear when the in-

crease will take effect, "We are working that out with the City Attorney right now," said Administrative Services Director Tracy Robinson. She mentioned the tentative start date is early

Add courthouses to the long list of things in California that are crumbling. Signed into law in September 2008, SB1407 "Launched an unprecedented courthouse rebuilding program in California by designating judicial branch revenues to fund up to \$5 billion in lease revenue bonds that will finance 41 new construction and renovation projects," noted the Office of Court Construction and Management. Of the 41 Courthouse projects from Alameda to Yolo County, none of the funds are going to Contra Costa County.

Proponents call the bill a major step forward to ensure the safety and security of courthouses and the improvements will not come from the cashstarved State General Fund, but rather court users.

Although many residents complain about the lack of parking downtown, the City of Lafayette is making a real effort to solve the problem. About \$250,000 is collected from parking tickets and \$120,000 from parking meters every year. That revenue goes into the Parking Fund and to support downtown maintenance, like medians, sidewalks, landscaping and Code Enforcement. Now at \$2,500,000, the Parking Fund money can only be used to buy

or build additional parking in-

Just recently a Parking Inventory was undertaken to quantify the parking problem in the Downtown Core and develop long term solutions. No surprise to folks who want to shop at Trader Joes on a Friday afternoon. City administrators are actively looking for properties to buy or lease in the downtown core.


