Finally as plates of homemade Member Carol Federighi and Transportation Planner Leah Greenblatt took the floor to discuss the proposed pedestrian and bicycle right of way. The recently completed feasibility study, funded by a grant from CalTrans, demonstrated that a walk and bike-way is indeed feasible along the one and a half mile EBMUD right of way from Risa Road to Brown Avenue. Further grants and more research is needed to move forward on the proposed project.


